Meeting Notes 05 12 08

Called to Order by President Dan Steffes

Secretary's Report -

Brenda DeGroot made motion to approve the minutes – Seconded by Sherry Steffes.  
Motion passed.

Treasurers Report – \$2648.45 with no recent expenses or income.

Payment for bags - Dan needs to provide.

Advertise the first week of practice.

Discussed making out a flyer for the buyer's guide.

Discussed getting information to the schools.

Old Prices - \$40 per child and \$35 for second season in a row (less \$5.00 for the second season). There have been price discounts for multiple children as well. If two or more, \$5 off for the second and additional children.

Example – Two children - \$75. Second Season in a row time - \$65 for two (for the second season) - \$35 each (this is less the \$5 off for the second continuous season and + \$5 off for the second in a family).

Prices with the bags – Add \$10 for the dues with the purchase of the bags - adding \$10 to the old price of \$40 = \$50 for the first season. For the second and third \$45 second (less the \$5 for for the second continuous season).
